All parents are given the opportunity to complete a paper or online Title 1 Spring Parent Survey. The results of the survey are tallied and shared with faculty members for their thoughts on ways to improve the PFEP for the next year. An evaluation of the current PFEP is conducted during a SAC meeting. Based on the survey results and staff input, the plan is revised for the next school year. The plan will then be reviewed during SAC meetings throughout the year to make revisions according to the changing needs of the parents and the school.

Parents will be involved in the joint development of the School Improvement Plan during SAC meetings. During the SAC meeting, results from a comprehensive needs assessment will be reviewed. Based on the parents' responses to the Spring Survey, 90% suggested that the faculty/staff could benefit from professional development that addresses Communicating with Parents. During Pre-school in-service days, the Title I coordinator will review the results of the spring survey with teachers and staff so they are aware of the best times, days, and ways to communicate with parents about conferences and events. Any other input parents offered to improve parent engagement will also be provided. This will be followed by training to address why communication is important and suggestions for what needs to be communicated to help engage parents in their child's education. Teachers will then be trained on the use of technology the school uses to communicate with parents and other means of communication for parents without technology.

The school will coordinate with the State Funded VPK program. All VPK parents will be invited to attend all events that the school holds to include Curriculum based and Transition Family Nights either virtually or in-person.

Based on the Title 1 Spring Survey Results, some parents requested help in understanding and using Parent Portal. For the 2022/23 school year, the school will offer individual virtual, phone, and in-person sessions for parents in the use of Parent Portal.

Based on the Title 1 Spring Parent Survey results, work schedule was listed as the top barrier to participation. We plan to offer pre-recorded virtual sessions for parents with schedule issues as suggested by parents in the spring survey. This will be done using Newsletters, Class Dojo, PeachJar, and social media.

All school communications will be available and translated for our ELL families. Google Translate and staff members assist with this. Bilingual staff members assist with conferences and phone calls.

Based on the Spring Survey Results, the majority of parents indicated that evening was the best time for them to attend an event. Other times (before school, morning, lunch, and after school) all received similar results.
