It will be advertised throughout the community via social media. During the meetings, parents will be given resources for their preschool child to

Parents will be given a tour of the campus. Additionally, in the fall, schools hold an Orientation to invite parents and families to visit the school, classroom, and teacher to become more comfortable with the school and to provide opportunities for parents to be involved.
