1. Reappointment of Curtis McNeil to Serve on the Citizens Oversight Committee (NEVES) (SMF #6)

Neves shared that this his 3rd reappointment of Mr. McNeil and has done a great job on this committee.

Motion by Register, seconded by Walker, to approve. Motion unanimously approved.

B. Human Resources & Employee Support Services

- 1. Request to Advertise New/Revised Job Descriptions (SMF #7)
 - a. School Psychologist (Certified)

John Cannon stated that currently Bay District Schools only has 1 job description and is in need of 2 descriptions.

Motion by Walker, seconded by Register, to approve. Motion unanimously approved.

b. School Psychologist (Licensed)

Cannon stated this description requires a specialist degree and also will have a higher salary reflecting the degree.

Motion by Walker, seconded by Register, to approve. Motion unanimously approved.

IX. PUBLIC HEARING – 1:45 P.M.

A. Bay District School Board Job Descriptions (SMF #8)

1. Principal

Register is concerned about the removal of teaching experience under #2 in Qualifications. He feels the Principal needs to have experience in teaching to understand the need and concerns of teachers and what they face every day in the classroom. Moss asked if it has been difficult to attract good candidates. Cannon stated it opens the field up to more candidates. Moss asked Walker if experience makes a successful leader. Walker stated it's not necessary but the experience would be preferable. Neves feels that opening up the job descriptions to a bigger pool that have more experience than the traditional setting. The staff will ultimately select the best qualified candidates.

Motion by Neves, hearing no second, Moss passed the gavel to Walker and seconded the motioned. Motion did not pass due to 2-2 vote with Register and Walker voting no.

2. Fine Arts Center Operations Coordinator

Cannon stated this is a part time position that will be paid on an hourly basis and at a level 0. Register asked if there is a need for a bachelor's degree. Burgans shared that the Gretchen Nelson Scott Fine Arts Center needs someone to run this center and to train students on using the equipment after school hours. She feels it needs to be a teacher due to student involvement. The hope is to eventually create an audio/visual academy. Bay High School will also have this need in the future.

Greg Dossie shared that he feels the bachelor's degree and teaching certificate should not be required due to many people have the technical experience without attending a 4 year college.

Motion by Register, seconded by Walker, to approve. Motion unanimously approved.
