Sharon Michalik spoke about our District Job Fair, 136 people were hired and half of them were substitutes, we still have job vacancies open within our District that need to be filled.

Sandy Davis spoke about the increase in the number of schools that will receive free breakfast and lunch this school year, 22 schools were automatically approved, the formula was done by the state, free/reduced applications are now online for parents to fill out. Alana Simmons and Kerri Weatherly spoke about the Foundations Academy for new teachers to help with success they have 100 new teachers signed up and will make sure they are ready before they hit the classrooms, 28% of teachers have 0-3 years of experience 55% are alt

certified, they are dissolving some district people and placing them at the schools to help support the schools and teachers, schools will have a Literacy Coach, Staff Training Specialist and new teacher Staff Training Specialist, at the District there will be a Science, Social Studies,

2 Math and 2 ELA Instructional Specialists, fall tutoring will begin in the fall, credit recovery will be all year long the numbers are reported by semester and summer credit recovery numbers will be coming out soon.
