#### 4. SECOND PUBLIC HEARING TO APPROVE 2022-2023 MILLAGE & FINAL BUDGET - 5:01 P.M.

Vice Chair Jerry Register stated that the Board is in session for the purpose of hearing from the public concerning the Final Millage Levy and Final Budget and for the Board to adopt a Final Millage Levy and a Final Budget.

Board Attorney Hudson advised that Section 1011.03(5), Florida Statutes, requires that the School Board hold a public hearing to adopt the Final Budget pursuant to Section 200.065, Florida Statues.

The hearing shall be primarily for the purpose of hearing requests and comments from the public regarding the budget and proposed tax levies and to explain the budget. The adoption of the budget and the millage levy resolution shall be by separate votes.

Prior to the conclusion of the hearing, the School Board shall amend the Final Budget as it sees fit, adopt the amended Final Budet, re-compute its proposed millage rate, and publicly announce the percent, if any, by which the re-computed proposed millage rate exceeds the roll-back rate.

The general public shall be allowed to speak and to ask questions prior to adoption of any measure by the Board. **The Board shall adopt its FINAL Millage Rate prior to adopting its FINAL Budget.** 

The first issue to be discussed shall be the percentage increase in millage over the roll-back rate necessary to fund the budget. the proposed millage necessary to fund this **Final** Budget exceeds the

roll-back rate by 11.03 percent. The School Board is required to levy 3.256 mills as Required Local Effort to participate in the Florida Education Finance Program and receive \$94,055,337 in State

Education funds. The Required Local Effort is .343 mills less than the mills levied in the previous fiscal year. Additionally, there is a proposed total Discretionary Millage of .748 mills to support the

General Fund Budget and a levy of 1.500 mills for Capital Outlay Projects. The funds derived from Capital Improvement Tax are to be used exclusively for construction and remodeling; maintenance,

renovation and repair; motor vehicle purchases; new and replacement equipment, computer and device hardware and electronic and digital instructional content and resources, and enterprise resource

software; payments for educational facilities and sites due under lease-purchase agreement; payment of loans approved pursuant to F.S. 1011.14 and 1011.15, payment of costs of compliance with

environmental statues and regulations; payment of premiums for property and casualty insurance necessary to insure the educational and ancillary plants of the district, and payment of costs of leasing relocatable educational facilities.

The total proposed millage levy is 5.504 mills which is .343 mills less than the 2022 levy of 5.847. The Required Local Effort which is required by the State has decreased by 9.53% and represents approximately six tenths of the total proposed taxes.

The second issue to be discussed is the Final Budget. The general public shall be allowed to speak and ask questions prior to adoption of any measures by the School Board.

Vice Chair Jerry Register asked if there is anyone from the public that wants to address the Board on the millage rate and/or the Final Budget.
